

1998 President's Letter

Recently, I had the opportunity to attend the AIA National Convention in San

Francisco. This year's conference was held at the Mascone Center. The convention had an overall attendance of some 17,000 people. There were at least 40 AIA Nebraska members who attended, many of which I was fortunate enough to see while I was there. The theme this year was "Bridges" which was appropriate not only because it was held in the *City of Bridges*, but also because of the analogy to many aspects of our profession.

There were a tremendous number of seminars and city tours available. The trade show space accommodated hundreds of exhibitor displays, many of which were brand new products. It was a great opportunity for me to meet and exchange ideas with other AIA members from around the country.

At this writing, members of the AIA are about half way through the first full year of the AIA's Continuing Education System (CES). Recently, I received a report outlining the 1998 CES statistics for all components across the country. Nebraska currently ranks 11th in the country of members that have completed their 1997 requirements and 5th in the country of members that have completed their 1998 requirements.

While these statistics speak well for Nebraska members as a whole, there is still work to be done. As I am sure you are all aware, members who have not met the CES requirement for the years ending 1997 and 1998, may not have their membership renewed in 1999 by AIA. It has been my long standing belief that the vast majority of our members are, and have been pursuing continuing education opportunities for years, long before the AIA instituted the CES program. For many of us, we simply have not taken the time to fill out the forms and send them in to receive the credits.

Early this year, you should have all received a CES report showing exactly where you stand. I would ask you all to review your status and take a few minutes to see that all programs you have attended are properly documented.

Should you find that you still need Learning Units (LUs) to fulfill your CES requirements, I would take this opportunity to give a plug to our Annual Design Conference to be held in September 17-18 at the Holiday Inn Downtown Lincoln. This year's conference will have numerous Learning Units offered to our members. This is a terrific opportunity to finish up your requirements. If you are unsure of your current status, please call AIA/CES at 800/605-8229, Gayle Krueger, CAE at 402/472-1456, or myself at 402/330-5555 to get a copy of your current standing.

Centennial Opps

The Trans-Mississippi and International Exposition opened June 1, 1898. The goal was to promote the products, progress and resources of states and territories west of the Mississippi River. The exhibits were housed in a series of elaborate but temporary buildings. The centerpiece of the 184-acre site was the Grand Court, designed by Thomas Kimball, FAIA, the expo's lead architect.

AIA National Annual Business Meeting Results

Members Vote for Three-Year Ad Campaign.

Delegates at the annual business meeting voted in favor of a bylaws change that will delegate to the Board of Directors the authority to levy an annual assessment of \$50 per member in the years 1999, 2000, and 2001 to support a national television advertisement campaign. The money collected through this assessment is to be used exclusively for the campaign.

Delegates also approved a bylaws amendment to allow the Board to confer honorary membership on presidents of national and international professional architectural associations.

A motion to delegate authority to the Board to amend the bylaws to create a nonvoting class of membership for AIA students failed.

Delegates also voted on and passed two resolutions:

Resolution 98-2, The Architectural Registration Examination (ARE), resolved that the AIA shall strongly advise NCARB to immediately evaluate recommendations of the AIA task force on the exam and to reduce the cost of the exam as soon as possible. Resolution 98-3, Copyrighted American Institute of Architects Documents, resolved that elected and appointed leaders of the AIA and its components shall encourage all members to respect the copyright of AIA documents. Resolution 98-1, CES/State Board Reciprocity, which proposed that any member meeting a state's mandatory continuing-education requirements will be deemed to have satisfied the AIA's continuing education requirements, was withdrawn.

As is traditional, the delegates also voted to extend appreciation to retiring board members, the host chapter and convention committees, exhibitors, and Ronald Arthur and Alice Altoon. Congress passed the Fair Housing Amendments Act in 1988. The Amendments expand coverage of Title VIII to prohibit discriminatory housing practices based on disability and familial status. The Fair Housing Act establishes design and construction requirements for multifamily housing built for first occupancy after March 13, 1991. The law provides that a failure to design and construct certain multifamily dwellings to include certain features of accessible design will be regarded an unlawful discrimination.

Under the Fair Housing Act, HUD is not required to review plans or issue a certification of compliance with the Fair Housing Act. *The <u>burden of compliance</u> rests with the <u>person or persons who</u> <i>design and construct*
